# #ReleaseESI



In the context of the EDSSI project, GÉANT works with eduGAIN and National R&E Federation Operators to ensure they can help HEI to release all required attributes including the ESI.

Meetings are being organised with the Digital Officers, via MyAcademicID projects, DG-EAC and EDSSI to share information.

# #ReleaseESI Scenario 1

## Scenario 1: Student from HEI can authenticate to services using their institutional account/eduGAIN

In this scenario the HEI is already connected to the National Academic Identity Federation and users can authenticate to services across borders via eduGAIN. In this case, the HEI needs to implement:

1. Attribute release

# #ReleaseESI Scenario 2



## Scenario 2: Student from HEI can NOT authenticate to services from eduGAIN

- The HEI should contact their National Federation operator and join the National Federation and eduGAIN as an IdP:

- Then go to Scenario 1

# #ReleaseESI Scenario 3

## Scenario 3: HEI cannot operate an IdP

- Contact the National Federation Operator:

- Investigate whether there is an alternative solution that can be provided by the National Federation, such as an IdP of Last resort or a hosted IdP Service.
- If this is the case, then they need to make sure that the ESI is supported and there is proper attribute release like in scenario 1.

## #ReleaseESI Scenario 4

**Scenario 4: HEI cannot join the national federation as an IdP and there is no IdP of last resort OR hosted IdP Service in the Federation**

Then the Student Mobility IdP of last resort is there to help.

Some preparatory work is required that involves different parties.

## Scenario 4 in more details

### Scenario 4: HEI cannot join the national federation as an IdP and there is no IdP of last resort OR hosted IdP Service in the Federation (1/2)

- National Agency gathers information about the HEIs under scenario 4 and sends this information to DG EAC
- DG EAC informs the Operator of the MyAcademicID IAM Service
- The Operator contacts the national identity federation and verifies that the HEI cannot be served by its federation (the whitelist is now created)
- Invitations are sent to the HEI representative to register on the MyAcademicID platform

### Scenario 4: HEI cannot join the national federation as an IdP and there is no IdP of last resort OR hosted IdP Service in the Federation (2/2)

- The HEI representative registers on the MyAcademicID platform and is assigned the role of the representative of that HEI
- The HEI representative can enrol students from her HEI that will be going to mobility. In the enrolment process the following information will be required for each student: Name, e-mail, identifier within the HEI.
- Enrolled students receive an invitation to register on MyAcademicID using their national eID
